SECTION 4 - FIRST AID MEASURES

EYES:	Check for and remove contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.

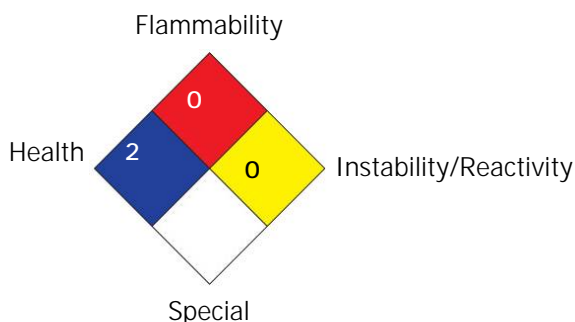
